



Morristown Partnership Board of Trustees 2020 OFFICIAL ELECTION BALLOT



There are five (5) seats available for the upcoming three-year term beginning August 1, 2020* and ending April 30, 2023. You are entitled to vote if you are a commercial property owner or business meeting Special Improvement District (SID) membership requirements.

- Each member property is eligible to submit one (1) ballot. Votes must be cast by the entity that owns the property or the official designee of the property.
- Each member business is eligible to submit one (1) ballot. Votes must be cast by the entity that owns the business or the official designee of the business.
