**ORDINANCE AMENDING AND REVISING ORDINANCE O-42-93 WHICH CREATES  
A SPECIAL IMPROVEMENT DISTRICT WITHIN THE TOWN OF MORRISTOWN  
AND DESIGNATED DISTRICT MANAGEMENT CORPORATION**

Purpose: Notice is hereby given that the Town Council of Morristown will hold a public hearing to consider amendments to the Ordinance O-42-93, as subsequently amended by Ordinances O-37-94 and O-14-95, establishing and managing the Morristown Special Improvement District (SID). The proposed amendments update the list of properties included in the SID (known as Schedule A) and define the criteria to reflect current zoning and property classifications as guided by New Jersey Property Tax Qualification Codes. Enclosed herewith, please find a copy of Ordinance No. O-26-25, introduced and approved on first reading by the Town Council at its meeting on June 12, 2025. The ordinance is available for public inspection at the Town Clerk's Office.

All interested persons shall be given an opportunity to be heard concerning this ordinance. The time and date for public hearing are subject to amendment by the Town Council of the Town of Morristown.

**ORDINANCE O-26-2025**

**ORDINANCE AMENDING AND REVISING ORDINANCE O-42-93 WHICH CREATES  
A SPECIAL IMPROVEMENT DISTRICT WITHIN THE TOWN OF MORRISTOWN  
AND DESIGNATED DISTRICT MANAGEMENT CORPORATION**

**WHEREAS**, the Town of Morristown (the “**Town**”) has heretofore adopted Ordinance O- 42-93, as amended by O-37-94 and O-14-95 (as amended, the “**Ordinance**”), which created a Special Improvement District in the Town pursuant to the enabling legislation, *N.J.S.A. 50:56-65, et seq.* (the “**SID Statute**”); and

**WHEREAS**, the Morristown Special Improvement District (“**SID**”) was established by the Ordinance to include those properties set forth by block and lot in Schedule A annexed to the Ordinance; and

**WHEREAS**, the Town Council (“**Council**”) designated Morristown Partners, Inc. *d.b.a.* the Morristown Partnership (the “**Partnership**”) to serve as the district management corporation for the SID; and

**WHEREAS**, since its inception, the Partnership has improved the long-term economic and social wellbeing of the local property owners, business operators, residents and visitors of the SID and community; and

**WHEREAS**, since the Ordinance was last amended in 1995, numerous properties have changed uses and new construction has taken place, as a result of which there are new and additional properties that benefit from SID programs and projects, but which have not been subject to special assessment due to the fact that they were not previously listed in Schedule A; and

**WHEREAS**, in addition to those properties which have changed use or upon which new construction has taken place, the Council further finds that additional properties have and/or will benefit from inclusion in the SID; and

**WHEREAS**, the Council is therefore desirous of revising the SID to include those properties set forth by block, lot and property address on the Schedule A annexed to this ordinance; and

**WHEREAS**, the Council finds that the properties included in the SID herein will benefit from being a part of the SID and that the Partnership would provide administrative and other services to benefit such properties; and

**WHEREAS**, the Council further desires to amend the Ordinance to provide that properties located within the SID be specially assessed uniformly in proportion to real property assessments as established by the Town's tax assessor as set forth herein; and

**WHEREAS**, the Council further finds that the continuation of the SID, as contemplated herein, and the continued designation of the Partnership as the district management corporation for the SID is in the best interest of the Town and the public.

**NOW, THEREFORE, BE IT ORDAINED**, by the Town Council of the Town of Morristown being the governing body thereof as follows:

1. Sections 4(a) and 4(b) of Ordinance O-42-93 are hereby deleted in their entirety and replaced with the following language:

(a) There is hereby created and designated within the Town of Morristown a Special Improvement District to be known as the Morristown Special Improvement District consisting of the properties designated and listed on Schedule A, by tax lot, block number, qualification code and property address. The properties set forth on Schedule A shall be subject to special assessments in accordance with the provisions of subsection 4(b) below. Such assessment shall be imposed by the Town of Morristown and transferred to the Morristown Special Improvement District for the purposes of promoting the economic and general welfare of the district and the municipality.

(b) All properties located within the Special Improvement District, including, but not limited to, all properties classified by the Town's Tax Assessor as 1, 4A, 4B, 4C and 15F in accordance with the New Jersey Property Tax System Qualifications, *N.J.A.C.* 18:12- 2.2, shall be subject to a special assessment with the exception of the following:

(i) Properties classified by the Town's Tax Assessor as a Class 2 property.

(ii) Properties classified as a Class 1 property which are located in the R Zone, the MF-1 Zone, or the PP/PPU Zone. Class 1 property located in any other zone are subject to a Special Assessment.

(iii) Properties classified by the Town's Tax Assessor as a Class 15A, 15B, 15C, 15D, and 15E property.

(iv) Properties which are classified by the Town's Tax Assessor as a Class 15F property, if the classification is pursuant to an exemption granted under *N.J.S.A. 54:4-3.6*, as amended and supplemented. This provision shall not apply to properties which are subject to a tax exemption or tax abatement pursuant to the Long Term Tax Exemption Law, *N.J.S.A. 40A:20-1, et seq.*, or the Five Year Exemption and Abatement Law, *N.J.S.A. 40A:21-1, et seq.*

(v) For those properties of which only a portion is exempt pursuant to (i), (ii), (iii) or (iv) above, the portion which is not subject to such exemption shall be subject to a Special Assessment.

(c) Properties not subject to a special assessment pursuant to subsection 4(b) above shall not have any membership privileges of the Morristown Partners, Inc., including, but not limited to, voting rights, except as provided in the By-Laws of the Morristown Partners, Inc.

2. Schedule A to Ordinance O-42-93, as amended by Ordinances O-37-94 and O-14-15, is hereby repealed and replaced by the Schedule A annexed to this Ordinance.

3. Section 5(b) of Ordinance O-42-93 is hereby deleted in its entirety and replaced with the following language:

(b) Each year, when the Mayor and Council shall have acted on the estimated costs and/or on the budget of the District, the assessor shall prepare an assessment roll setting forth separately the amounts to be specially assessed against the properties in the District in accordance with Section 4(b) of this ordinance. Descriptions of such properties, and the names of the then current owners of such properties, so far as names are available, shall be included in each annual assessment roll. The assessment roll, when so prepared, shall be filed in the office of the municipal clerk and be there available for inspection. The Council shall annually meet to consider objections to the amounts of such special assessments at least 10 days after a notice of hearing has been published once in the official newspaper and mailed to the named owners of all tracts, parcels and lots of property proposed to be assessed. The notice shall set forth the time and place of meeting, and set forth the purpose of such meeting, but may refer to the assessment roll for further particulars. When the governing body shall have approved the amounts set forth therein, the municipal clerk shall forthwith

certify a copy of the assessment roll to the Morris County tax board.

(c) The assessment roll and Schedule A shall also be posted online for public access.

4. The Town Tax Assessor, in consultation with Morristown Partners Inc., shall conduct an annual review of the SID to determine whether updates to the boundaries, assessments, or Schedule A are necessary to meet the district's goals. The Town Tax Assessor shall memorialize the review in a report and present the findings to the Town Council.

5. Coordination with Chapter 30, Land Development and Redevelopment

(a) The "Attachment 1 - Land Use Application," as referenced in Chapter 30 - Land Development, shall be amended to include the following question:

(i) **Question:** "Are any of the properties under this application located within the Special Improvement District (SID)?"

(b) In cases where any property within the application lies within the SID, the Zoning Officer shall forward the approved resolution from the Planning Board or Zoning Board of Adjustment to the Town Clerk.

(c) The Town Redevelopment Entity shall similarly notify the Town Clerk of any redevelopment plan or amendment to an existing redevelopment plan that includes properties within the SID.

(d) Upon receipt of the resolution, the Town Council shall consider an ordinance to amend Schedule A to reflect any necessary updates resulting from land use changes, such as, but not limited to, lot consolidation, subdivision, or changes in property use.

6. Severability. If any section, paragraph, subdivision, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause, or provision, and the remainder of this Ordinance shall be deemed valid and effective.

7. Repealer. All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

8. Effective Date. This Ordinance shall take effect upon passage and publication as required by law.
