## 2026 SELF-NOMINATION APPLICATION



Self-nominations for five (5) seats on the Morristown Partnership Special Improvement District’s Board of Trustees are now being accepted from members who wish to serve for a three-year term beginning May 1, 2026 through April 30, 2029. Nomination forms must be received in the Morristown Partnership office by 5pm on Monday, March 23, 2026. The 2026 election will be conducted by mail in April.

In order to be listed on the Ballot of Nominees, you must be a Special Improvement District (SID) member. Members of the SID, as defined in the Corporation’s By-Laws, include owners of commercial real estate subject to assessment, owners of businesses operating within an assessed property and authorized representatives or employees of a business owner operating within an assessed property in the SID.

Responsibilities of a Trustee: Have a fervent interest in downtown Morristown’s future. Attend monthly Board meetings held 8am on the second Wednesday of each month at the Morristown Partnership office. Comply with the SID’s Conflict of Interest Policy. Participate in Board Sub-Committees. Support Morristown Partnership community events and/or Annual Appeal. Attend networking events twice a year, as well as the Morristown Partnership Annual Meeting.
